

Eureka Farms Pet Resort Boarding Contract

This agreement is between Eureka Farms Pet Resort LLC (EFPR)/ Carolyn Bell and the owner or guardian of the pets in their care. EFPR agrees to keep its boarding areas sanitary and to adequately feed and water the pets in its care. All pets are either boarded, groomed, trained, day-care, transported by pet shuttle, visited in home or otherwise handled or cared for by Eureka Farms Pet Resort without liability. This includes, but not limited to: Loss or damage from disease, injury, death, running away, theft, fire, act of God, accident, injury to persons, other pets or property by said pet, or injury incurred by other pet(s), or other causes. Let it be known that some boarding dogs are involved in group play unless you have specified otherwise (please specify on boarding info sheet), and due to the nature of group play, the risk of accident and/or injury is present and the owner(s) of pets agree to not hold EFPR liable. Let it be known that EFPR allows, but does not recommend, pets that are seniors or pets with chronic conditions to board because boarding can be stressful to the immune system. If a pet, which is presented for boarding is found to have fleas and/or ticks, it will be bathed and treated with Capstar for fleas at the owner's expense. EFPR tries to maintain a flea-free environment, but is not responsible for occasional occurrences. Vaccination requirements have been made known by EFPR to owner, but are not 100% guaranteed to prevent illness. By signing this contract, the owner is certifying that their pet(s) is in good health for boarding and vaccines are current within 1 or 3 years (Rabies/DHPP) within 1 year (Bordatella) and has been dewormed or negative fecal test within 6 months) and that their pet is not aggressive. The pet is not to be taken off the premises except by the consent of the owner. If the pet becomes ill or an accident occurs, the owner shall be notified at once if able to be reached. If the owner is not available or if owner does not inform immediately regarding measures to be taken, or if the state of the pet's health reasonably demands quick action, EFPR shall have the right to call a veterinarian, as designated in client file (when possible), or if no veterinarian is designated, to call a veterinarian of EFPR's choice or take pet to said veterinarian in either case; or administer medicine or give other advisable attention, within EFPR's discretion and judgment, without liability, and such expenses shall be paid promptly by the owner of the pet. If any charges for boarding, grooming, training, day-care, medicine, transportation, other services or veterinary services are not paid upon pick up of your pet, or if pet is not called for or the reservation extended within five days after designated time for return of pet, the pet will be considered abandoned and will be re-homed or turned over to local Animal Control or other rescue group (EFPR's choice) by EFPR. Expenses will still be owed to EFPR and legal action will be taken to collect if necessary. I also agree to keep my pet on a leash or in an enclosed crate while on premises or during pet shuttle service until handed over to EFPR staff.

I UNDERSTAND and hold harmless also for THE FOLLOWING:

- That if I do not request a departure bath (which is at courtesy rate), my pet(s) may be "dirtier" and "smellier" than when they arrived, due to the nature of outdoor playing/possible rain, etc.
- That when playing outside or in play groups, there might be some minor "bumps, scuffs, limping" to my pet(s).
- That my pet(s) might lose weight due to the exercise or possibly due to not eating as well from the changes in environment and schedule.
- That my pet might have diarrhea due to change in water or change in food/treats or possibly stress.
- That if I bring items for my pet, they might not be returned in the same condition as they arrived, if at all

I agree to pay the current boarding price, plus any extra charges incurred, promptly at the time before my pet is released. I understand the above conditions and the risks involved and I am releasing EFPR of any liability. I understand that the provisions in this agreement apply to this day below AND ALSO any future time, that the owner listed below, boards the same or other pets in their custody, whether or not this agreement is signed at each visit. I hereby agree to the contract as owner/guardian of the pet(s). I certify that my pet is current on vaccinations or titers and is in healthy physical condition for boarding. In consideration of Eureka Farms Pet Resort accepting my pet for boarding, I do hereby release, discharge and waive claims, demands, and/or actions against Eureka Farms Pet Resort, its agents, employees, officers and insurers arising from or relating to injury, illness, accident or death that may occur during the period of boarding, shuttle or other services at Eureka Farm Pet Resort.
